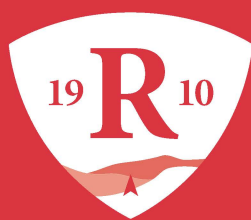

**Call to Order**

Dr. Debra K. McMahon, Rector, called the meeting to order at 8:02 a.m. in the Dean's Conference Room in Kyle Hall.

**Approval of Agenda**

Rector McMahon asked for a motion to approve the December 1, 2023 meeting agenda, as published. Mr. Robert Archer so moved, Mr. Marquett Smith seconded, and the motion carried unanimously.

**Approval of Minutes**

Rector McMahon asked for a motion to approve the Sept. 7, 2023 and Sept. 8, 2023 minutes of the Executive Committee meeting in a block with no objections. Mr. Tyler Lester so moved, Mrs. Jennifer Gilbert seconded, and the motion carried unanimously.

### **President's Remarks**

President Bret Danilowicz shared his excitement that his cabinet is now staffed with permanent vice presidents and shared that the working relationship among the members is exceptional. President Danilowicz provided an overview of the Radford Tuition Promise, budget outlook and the Two-Year Strategic Plan to be voted on at the full board meeting. President Danilowicz shared that the plans are for the Board Retreat in July to be held at Berry Hill in South Boston, Virginia.

### **Committee Discussion and Updates**

Rector McMahon led a discussion with committee members on issues raised during the committee meetings held on Thursday, including Radford Tuition Promise, enrollment and the Governor's upcoming budget announcement.

### **Other Business**

Rector McMahon and committee members confirmed the Board's support of the Radford Tuition Promise and suggested that a vote to ratify be held during the full Board meeting.

Rector McMahon shared that per the Board of Visitors Bylaws, the Board approves the hiring of the President's direct reports and that with the hiring of Penny Helms White as the Vice President for University Advancement, the item would be brought before the full Board.
