REPORT FROM THE PRESIDENT OF THE STUDENT GOVERNMENT ASSOCIATION

Mr. Colby Bender, President of the Student Government Association (SGA), referred the Committee to his report found in the Committee's board books. He highlighted several items, specifically noting that SGA Elections will be held at the end of September, and that the Voter Action Office on campus, which is a partnership with the Radford City Registrar of Voters, has recently completed training of approximately 18 student volunteers. He noted that the Voter Action Office model created by Radford University is now being implemented by other institutions of higher education in Virginia. STUDENT AFFAIRS REPORT

Dr. Mark Shanley, Vice President for Student Affairs, referred the Committee to his report found in the Committee's board books. Dr. Shanley provided an overview of the fall 2015 opening initiatives for students, including move-in, first week-end on campus and new student convocation. He also reported on staffing changes within the Student Affairs Division and updated the Committee on the Student Affairs Vision, Mission and Goals. Threat Assessment Policy
