CALL TO ORDER

Mr. Michael A. Wray, Rector, formally called the subcommittee meeting of the Search Firm Subcommittee to order at 2:45 p.m., in the Frank & Albert's Restaurant in the Arizona Biltmore, 2400 E. Missouri, Phoenix, Arizona.

CLOSED SESSION

Mr. Wray moved that the Subcommittee of the Search Firm Subcommittee of the Board convene a closed session under the Virginia Freedom of Information Action Section 2.2-3711(A) 29 to discuss award of a public contract involving expenditure of public funds where discussion in open session would adversely affect our bargaining position.
