#### **APPROVAL OF MINUTES**

Ms. Campbell asked for a motion to approve the minutes of the November 20, 2014 meeting of the Student Affairs Committee, as published. Ms. Robinson so moved and Ms. Rogers seconded the motion and the motion carried unanimously.

# REPORT FROM THE PRESIDENT OF THE STUDENT GOVERNMENT ASSOCIATION

Mr. Colby Bender, President of the Student Government Association (SGA), provided updates on several SGA initiatives including the T-shirt clothing drive with the Radford Clothing Bank, the Class Ring Ceremony, and the SGA Centennial Celebration which was held in March 2015. In addition, Mr. Bender provided the Board with an update on the SGA elections and introduced the SGA executive committee for the 2015-2016 academic year.

Mr. Bender also noted that the Committee materials included two acts that were passed by the SGA specifically, Accelerated Registration Act of 2015, which requests that an "Accelerated Registration" group for dual major students be added to allow them to register between the special population and non-graduating seniors; and the Academic Equity Act of 2015 which requests that printers be located in the residence halls on Radford University's campus. #### STUDENT AFFAIRS REPORT

Dr. Mark Shanley, Vice President for Student Affairs, referred the Committee to his detailed report found in the Committee's board books and provided updates on several activities/initiatives of the Student Affairs division including updates on the student usage of the new Fitness and Wellness Center noting that there are approximately 8200 users a week, the development of two new residential learning communities, the recent Student Awards ceremonies and the creation of the SALUTE Veterans award. He also updated the committee on the implementation of OrgSync software for the RU Involved student organization portal. Dr. Shanley also reported that the new Intermural fields are scheduled for completion in July 2015. A copy of Dr. Shanley's report is attached hereto as *Attachment C* and is made a part hereof.

Ms. Campbell thanked Dr. Shanley for his report.

Mr. Robert Bedford, Director of Student Involvement, provided a presentation on the 7 *C's of Social Change* model which emphasizes the need to understand self and others in an effort to create community change. He noted that the primary goals of this model are to facilitate positive social change at the institution or in the community; and to enhance student leadership and development. A copy of Mr. Bedford's presentation is attached hereto as *Attachment D* and is made a part hereof.
