# STUDENT AFFAIRS REPORT

# **Division of Student Affairs Report**

Dr. Mark Shanley, Vice President for Student Affairs, provided an update on new hires in the Student Affairs Division, and introduced Dr. Irvin Clark as the new Associate Vice President and Dean of Students. He also provided an overview of the fall semester commenting that the move-

in process for new students and their families went extremely well and was a collaborative effort by the entire Radford University community. Dr. Shanley also informed the Committee about the Greek Leadership Training Program which includes an Executive Seminar Series and an IMPACT retreat for upcoming fraternity and sorority leaders. He also acknowledged a generous gift from Phi Kappa Sigma fraternity alumni to support this program.

#### **Dean of Students Report**

Dr. Irvin Clark provided an oral report on recent developments in his department including the increase in the number of students seeking assistance from the offices of Disabilities Services and Support Student Services. He noted that residential housing remains at 98% occupancy and that student feedback on the renovations at Washington Hall have been very positive. He also reported that the Center for Diversity and Inclusion has sponsored a number of successful fall events.

#### **Student Activities Report**

Mr. Kenneth J. Bonk, Associate Vice President for Student Affairs/Student Activities, provided an oral report that included updates on Family Weekend/Alumni Homecoming, student leadership initiatives, and an update on the student fitness/wellness center. Mr. Bonk indicated that student engagement levels in leadership, student organizations, and late night programs continue to grow, and that several new leadership programs have been introduced this fall.

Ms. Rogers thanked Dr. Shanley, Dr. Clark, and Mr. Bonk for their reports.
